The PHA is also working with the local municipality to redevelop a decommissioned water reservoir site into 34 buildable lots to construct affordable homes for sale. The grading and demolition phase of the work was completed in early 2025. PHA offers assistance through its Housing Choice Voucher program, to the elderly, disabled, low-income, homeless, and veterans. In addition to operating the HCV program for The City of Fort Smith, the PHA partners with Crawford-Sebastian Community Development Council both to rehabilitate existing homes and to construct new homes using Community Development Block Grant and HOME funds. The PHA has also partnered locally with Next Step Homeless Services to construct transitional housing for homeless families.
